1841 District 3

"All that part of the Parish of Mobberley from Brown Hedge (*Spring Gardens at end of Stubbs Lane*)by Grave Yard and Moss Lane thence by Isaac Summer's (*Lindow*) near Morley, Burley Hurst and Mr Hargreaves farm (*Hazlehurst Farm*) to Mobberley Church including part of Wood Iane"

1841

"All that part of the Parish of Mobberley from the Revd Mr Mallory's Hall by Altrincham Road to Pepper Street and Mrs Dooley's farm *(Birtles Farm)*, thence by Tatton Park, Four Lane Ends and Vale Wood to Mobberley Church"

1851 District 4a

"All that part of the Parish of Mobberley comprising the Rectory, Mobberley Hall, Mobberley Mill, Dam Head, Town Lane, Pavement Lane, Duckinfield Hall, Broad Oak Lane, Smith Lane to Birtles Houses, Pepper Street, New Mills, Breach House, Stockin Hay, Wood Lane, Baguley Green and Road to Wrights' Arms"

"Part of the Parish of Mobberley lying on the right hand side of the Road from Antrobus Hall to Knowles Green along Newton Hall Lane past Mr Hargreaves house *(Holt House)* past Orrell House to Wood End including Mr John Bracegirdle's farm *(Wood End Lane)*, Mr Elijah Burgess Farm *(Wood End)*, Bollin House, Bleakley, Birley Hurst, Mr Nathan Hulme *(Lindow End)*, Saltersley, Hollin Gee, Moss Lane, Paddock Hill, Yew Tree Farm and Mr Thomas Bradbury *(Brown House)* and Mr James Daniels *(Dubbed Hedge)* and in the Ecclesiastical Parish of Mobberley"

1881 District 6

"All houses on the South West Side of the River from Antrobus Hall to Heald Mill, including Coppock House, Pavement Lane, Gleave House, Dam Head, Duckinfield Hall, Park House, Smith Lane, Broad Oak Lane, houses in lane leading to Mr William Worthington's farm *(Birtles Farm)* inclusive, Pepper Street, New Mill, Mobberley Station and Signal Box & Heald Mill. The whole in the Parliamentary Division of Knutsford. Inhabited houses103. Separate families 103"

1901 District 9

"From Bird in Hand Inn both sides of Newton Hall Lane to Dicken House and Birley Hurst, Mrs Hulme's *(Mossways Cottage Lindow End)*, Saltersley, Hollingee, Moss Lane, Graveyard Lane, Paddock Hill to Joseph Hatton's house *(Paddock Hill)*, Lindow House Farm, Mr P F Norbury's Farm, Mr P Frost's house, Yew Tree Farm, Brown House, and Dubbed Hedge Farm."

1901 District 10

"From Antrobus Hall to Knowles Green thence past Holt House to Wood End, Bollin House, Bleackley and all houses on the North side of the river from Heald Mill to Antrobus Hall including Wood Lane, Mobberley Hall but not Breach House nor Mr Ashton's Cottage in Breach House Lane"

1901 District 11

In 1911 the process changed and households filled in their own information. There was no frontispiece explaining the route of an enumerator. Below is an interpretation based on the order in which households appear in the census produced.

1911 District 9

The Lodge (New Hall) along Hall Lane and pick up Antrobus Hall then bypassing Newton Hall Lane, straight up to Davenport Lane via Holt House. Up Lady Lane to Mere House and along Ostlers Lane to Orrell House, Wood End Farm, Bollin House, down to Hill House and along Wood Lane to Stock in Hey, back to Wood Lane and west to Owen House. Down Small Lane to Green Bank Farm, via Slade Lane to Heald Mill Farm and across fields to Vale Wood and again to Church Lane. Back up to Hobcroft Lane and retracing to Tipping Brow, Hall Bank and along Hall Lane past Old Hall to Mobberley New Hall

1911 District 10

Coppock House, Damson Lane, Mobberley mill then along Town Lane to Pavement Lane, Gleave House, Booth's Mill and then back via Broad Oak Lane to New Mills, touching West end of Wood Lane (Clay House and Bullens Croft) down to Baguley Green, Spring Bank, Smith Lane, The Railway, Kell House, Birtles Farm, Barnshaw Cottages and finishing in Pepper Street

1911 District 11

From Knoll's Green up Newton Hall Lane picking up Stubbs Lane and Brownedge Cottages (Spring Gardens) to Barnes Green, Holt House and Blakely Lane. Then along Burley Hurst lane to Mossways Cottage, Saltersley, Hollin Gee, Coppock House and then Moss Lane picking up Graveyard Farm and Moutn Pleasant and into Paddock Hill to the Plough & Flail, Barlow House and Londow, then down to the Wilmslow Road and picking up Brown House, Dubb'd Hedge, Clay Lane and back to Knolls green and the Bird in Hand
